### SECTION 3. HAZARDS IDENTIFICATION

#### NOTES TO PHYSICIAN

Contains petroleum distillate - vomiting may cause aspiration pneumonia.

#### SIGNS/SYMPTOMS OF EXPOSURE

Direct contact with eyes can cause irritation. Prolonged or repeated contact of product with skin may cause irritation. Product spray mist, fog or vapor may cause irritation to nose, throat and lungs. If taken internally, aspiration of liquid product may cause pneumonitis.

### SECTION 4. FIRST AID MEASURES

#### UNUSUAL FIRE, EXPLOSION AND REACTIVITY HAZARDS

#### IN CASE OF FIRE

**Extinguisher Media:** Foam, Dry Chemical, Water

**Special Fire Fighting Procedures:** Treat as an oil fire. Use water spray to cool fire exposed surfaces and to protect personnel. Isolate "fuel" supply from fire. Use foam, dry chemical or water spray to extinguish fire. Avoid spraying water directly into storage containers due to danger of boilover. This liquid is volatile and gives off invisible vapors. Either the liquid or vapor may settle in low areas or travel some distance along the ground or surface to ignition sources where they may ignite or explode.

### SECTION 6. ACCIDENTAL RELEASE MEASURES

#### IN CASE OF SPILL OR LEAK

If container begins to leak (through puncture, etc.), eliminate all ignition sources and absorb with oil-dry or similar inert material. Sweep or scrape up and containerize. Do not let spilled or leaking material enter watercourse. May be toxic to aquatic life. This product contains the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) listed chemical *Pyrethrins* which has a reportable quantity (RQ) of 1 lb. A release of more than 4.2 gal of this product is reportable to the National Response Center (800-424-8802).

#### PROTECTIVE EQUIPMENT

**Eyes:** Use proper protection – safety glasses are recommended.

**Inhalation:** Use of a respirator may be appropriate when working with spills in enclosed or confined spaces, or when prolonged exposure to product vapor or spray mist may occur. When using a respirator, wear a NIOSH approved respirator with an organic vapor (OV) cartridge or canister with any R, P or HE prefilter.

#### WASTE DISPOSAL METHOD

If in doubt, test by applying this material to an inconspicuous area before spraying.
